## **PUBLIC NOTICE**

On 22<sup>nd</sup> April,2021, I have checked randomly, the areas as specified above (from E-Sector, Nharlagun along NH-415 till Banderdewa) of trade activities and found trade license are not obtained from Itanagar Municipal Corporation.

Now, in view of the fact stated and finding and to regulate issuance of trades/business licenses under Itanagar Municipal Corporation jurisdiction this public notice is issued to all business community/ traders to apply or regularize trade licences within one month from date of issue of this public notice.
