PUBLIC NOTICE

In exercising the provisions under section 355 & 356 of Arunachal Pradesh Municipal Act 2007 and section 59 ( XIII ), section 69 (e) & (f) , 111, 112, 113, 245 & 256 (e) of Arunachal Pradesh Municipal Act 2019 read with the water (prevention & control of pollution, Act, 1974, Environment (Protection) act, 1986, Solid Waste Management Act & Rules, 2016 as well as green Tribunal Act and also in pursuance to the guidelines issued by the Central Pollution Control Board, the following norms and modalities are hereby laid out for strict compliance in public interest in respect of organizing Durga Puja/Festival within the IMC jurisdiction.

1. All the organizers of Durga Puja/festival organized under IMC jurisdiction are hereby directed to obtain permission from office of the Commissioner, IMC for erection of temporary structure/ booth/ pandal or any other structure within IMC jurisdiction for celebration of puja/festival under aforementioned sections to avoid punitive action upon inspection made by the festival monitoring committee constituted for the purpose.


