

**NOTIFICATION**

The following terms & condition are laid down to maintain rule of law within, Itanagar Municipal Corporation (IMC) on violators of Trade License Rule by the traders is as under:-

1. The Traders running their business without valid trade license shall be imposed a fine of Rs.5,000/- (five thousand)only- for 1<sup>st</sup> violation and Rs.10,000/-(ten thousand)only-for subsequent Violation. Law as provided under section (111), Arunachal Pradesh Municipal Corporation Act 2019 and Notification issued Vide No. DTC/TL75/2006/559-632 Dated 29<sup>th</sup> July, 2009.
2. Traders not selling items as per trade license shall be imposed a fine of Rs.1,000/-(ten thousand)only and said items will be seized.
3. Traders not running their business at the specified location as mentioned on the trade license shall be imposed fine of Rs.5, 000/- (five thousand) only for 1<sup>st</sup> violation and Rs.10,000/-(ten thousand)only for subsequent Violation including 2 (two) weeks ultimatum for change the location else Trade License shall be cancel within 2 weeks from date of ultimatum.
4. All the traders should display their Signed Board of a size of 6 feet x 2 feet (which will remained un changed but length can be reduced upto 3 ft.) mentioning the shop name and TL No. else a fine of Rs. 1,500/-(fifteen hundred) only shall imposed including 2 (two) week ultimatum for display Sign Board. As per Notification issued Vide No. DTC/TL75/2006/559-632 Dated 29<sup>th</sup> July, 2009.
5. All the traders should keep their original/ certified copy of Trade License in the shop, which can be produced on demand of IMC authority, failing which a fine of Rs.1, 000/-shall be imposed.
6. Trade License holder if found a Govt. employee, his/her Trade License shall be cancel with fine a sum of Rs.5, 000/-and necessary action shall be taken as the primary laws
7. If traders found on obtained TL on submission of false documents, his/her Trade License shall be canceled on the spot and fine of Rs.10, 000/- may be imposed and action taken as primary laws against the Proprietor.
