- Safeguarding the Interest of the weaker section of society, including the physically handicapped and mentally unsound.
- Urban Forestry, protection of environment and promotion of ecological aspects.
- 11. Construction of Roads and Bridges.
- 12. Provisions of Urban Amenities and facilities such as parks, gardens and playgrounds.
- 13. Promotion of Cultural, educational and aesthetic aspects.
